<b>Who can enter?</b>	<p>Entry is open to Australian residents only who are aged 13 or over at the time of entering the promotion.</p> <p>If you are under 18, you must get approval from your parent/guardian before you enter and if you will be under 18 on the date an instant win prize is awarded, it will be awarded to your parent or guardian. ### Entry

If you return a Qualifying Purchase your entry may be deemed invalid at the Promoter's discretion (unless the product is defective). You will receive a return message confirming your entry and whether you have provisionally won a prize. The Promoter is not liable for any problems with communications networks.
